No.GH/V-53 of 2021-AGN/10/2020/422/L1:- WHEREAS the Government of Gujarat has constituted the fire regions with their headquarters and local limits of such fire regions vide Government Notification, Urban Development and Urban Housing Department No.GH/V-320 of 2015-AGN/10/2015/2425/V, dated the 2<sup>nd</sup> December, 2015 and subsequent Government Notification No.GH/L1-154 of 2020-AGN/10/2020/422/L1. dated the 3<sup>rd</sup> October,2020;

AND WHEREAS the Government of Gujarat considers it necessary to reconstitute the existing fire regions for the purpose of effectively securing fire prevention and life safety measures within the State;

NOW, THEREFORE, in exercise of the powers conferred by sub-sections (1) and (2) of section 8 of the Gujarat Fire Prevention and Life Safety Measures Act.2013 (Guj.11 of 2013) and in supersession of Government Notification, Urban Development and Urban Housing Department No.GH/V-320 of 2015 –AGN/10/2015/2425/V, dated the 2<sup>nd</sup> December, 2015 and Government Notification No.GH/L1-154 of 2020-AGN/10/2020/422/L1, dated the 3<sup>rd</sup> October,2020, the Government of Gujarat hereby constitutes the fire regions with their headquarters as specified in columns (2) and (3) of the Schedule appended to this notification, respectively and defines the limits of such region as specified in columns (4) and (5) of the said Schedule.


