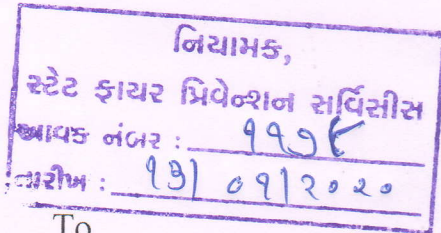
ORDER:-


The Government of Gujarat, in exercise of the powers conferred by section 57 of the Gujarat Fire Prevention and Life Safety Measures Act, 2013 (Guj.11 of 2013) has published the Gujarat Fire Prevention and Life Safety Measures Rules, 2014 (now referred to as the "said rules") vide Urban Development and Urban Housing Department's Notification No.GH/V/157 of 2014/PRCH-102013-382-L (Part-2), dated the 19th August, 2014.

Now, therefore, the Government of Gujarat hereby prescribes the following qualifications for the appointment of Nominated Officer as provided in First Schedule of rule-3 for the purpose of rule-46 of the said rules;

Sr.No.	Area	Qualifications
(1)	Municipal Corporation	1. Should possess a bachelor's degree. 2. Should not be below the rank of Deputy Municipal Commissioner in Municipal Corporation.
(2)	Municipalities, or Notified Area or Industrial Townships/Estate	1. Should possess a bachelor's degree. 2. Should not be below the rank of Deputy Collector in Revenue Cadre.
(3)	Special Investment Region and Special Economic Zones (SEZs), Private Townships	1. Should possess a bachelor's degree. 2. Should not be below the rank of Deputy Collector in Revenue Cadre.


